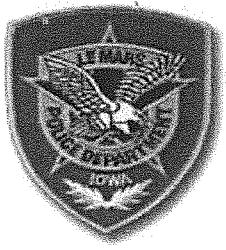

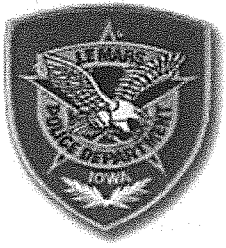

On the late evening of 12-30-2018, Le Mars Officers were made aware of possible under age drinking taking place at the 434 2nd Ave. SE. in Le Mars.

After checking into the complaint officers obtained a search warrant for the residence to further the investigation.

Once the search warrant was obtained officers made entry into the residence and discovered nearly fifty individuals inside the home.

Over the course of the investigation officers determined that thirty-two (32) of the subjects present had been consuming alcoholic beverages while being under the legal drinking age of 21 and many were intoxicated.

All the subjects were identified and released from the scene.

Those under the age of 18 were turned over to parents or other responsible parties.
